

TERMS AND CONDITIONS – Centre for Unsolvable Problems - CFUP

Article 1 Definition of terms

CFUP: Centre for Unsolvable Problems registered at the Chamber of commerce under number 32100074 Located in Utrecht, Netherlands.

Participant: is the person using the tool for Next Level Learning on www.nextlevellearningtool.com.

Exercises: the exercises described on the web page "Exercises" (subpage of the web page "How to achieve Next Level Learning").

Website or webpage: the whole site or a page of www.nextlevellearningtool.com

Article 2 Applicability

2.a. These terms and conditions apply to the right of using the tool for Next Level Learning.

Article 3 Conditions for use

3.a. To make use of the tool, a number of conditions must be met in general:

3.a.1. The participant has gone through the tool and is able to perform the exercises.

3.a.2. The participant has the intention to regularly repeat the exercises. When the participant is over 63 or under 20 years of age the effect of the exercises will be reduced. In this case the participant has to repeat the exercises very frequently. For participants in these age groups repetition of the exercises is even more important

3.a.3. Underage participants must have permission explicitly stated by their parents to use the tool.

3.a.4. The participant does not use drugs that affect the functioning of the psyche.

3.a.5. The participant is not addicted to alcohol, smoking or any other drug.

3.a.6. The participant does not have a psychological or physical illness that affects psychological functioning.

3.a.7. The participant is not depressed, extremely tired, burnt out, extremely tense and has no illness or disorder that causes tension.

3.a.8. The participant has read the webpage "Results and (side) effects".

3.b. The participant has to meet all items of the checklist as stated on the webpage "How to achieve Next Level Learning".

Article 4 Liability

4.a. Making use of the tool takes place entirely at the participant's own risk.

4.b. On the webpage "Results and (side) effects" the expected results and side effects are described so that the participant can make a realistic assessment of any risks.

4.c. CFUP cannot be held liable in any way for any damage that is associated with the use of the tool.

Article 5 Cancellation

5.a. CFUP will make reasonable efforts to keep the tool operational and available for participants (free of charge). CFUP reserves the right to discontinue this service and to take the tool offline for technical or business reasons. CFUP cannot be held liable in any way for the consequences of this, not by participants or any other party.

Article 6 Copyright
